Agreement to pay water and sewer bills: The undersigned applicant hereby agrees to pay all water and sewer service charges incurred in the use and utilization of the property described in the foregoing paragraph pursuant to the applicable chapter of the City Code for the City of Lebanon concerning same. The applicant understands and agrees to pay all bills for water and sewer services rendered within ten (10) days from billing date and that failure to make full payment thereof, as provided by law, may result in disconnection of service. The applicant absolves the City from liability for any damages the applicant may sustain if service is disconnected for non-payment of bills. Charges for water/sewer usage are in the Fee Schedule in Ordinance 1447. No adjustments are made on sewerage for watering, filling pools, etc.

5. City of Lebanon's Responsibility: The utility will endeavor at all times to provide regular and uninterrupted supply of service, but in case the supply of service shall be interrupted, irregular, defective or fail from causes beyond its control or through negligence of employees, servants or agents, the utility will not be held liable, therefore. The City shall have the right to shut off utility service whenever it is necessary to make repairs, improvement, for non-payment of bills, to enforce rules or for any operating reason.

6. Deposit: The applicant agrees that he shall not be entitled to any interest on his deposit.

7. Unpaid bills: Applicant understands that water will not be connected if a previous bill has been left unpaid at a different service address by the applicant or his/her spouse.

8. Water Meter: Consumer shall be responsible for any water meter damage other than ordinary wear.

9. Effective Date: This application is effective on the following date and shall continue to be in force and effect until notice is given to the City Clerk/Collector to terminate water and sewer service to the aforesaid described service location.
