LEBANON CITY COUNCIL MINUTES December 11, 2023, at 6:30 p.m.

The council met in regular session at city hall was called to order 6:30 p.m. by Mayor Wright.

- 1. John Cummins stated his opposition to the allowing of electronic billboards at 765 True Value Dr. The electronic billboards should be kept to along interstates.
- 2. Barb Cioni stated her concern over the non-issuing of traffic tickets after her car was hit on West St Louis St in front of her house. The Police Chief stated the issuing of tickets is at the discretion of the officer.
- 3. Lori Cummins stated she sympathized with Mrs. Cioni situation. She too was opposed to the Electronic billboards and that Lebanon is starting to look like Vegas.
- 4. Bill Millikin of Ace Hardware informed the audience of some off the mistaken facts that are going around. He stated the billboards are not as bright as the BP lights.
- 5. Robert Wilhelm spoke about his support for the Biker/pedestrian Trail being discussed. This went back to committee and was talked about later in the meeting under Unfinished Business.
- 6. Tanner Wolk stated the brightness of the billboards will only be 1.3 foot candles which has sensors That will keep the light at a regulated brightness.
- 7. Debra Trame stated she is not against the trail but it would be hard to justify spending money on the bike path when the city's limited funds are having a hard time keeping the infrastructure in repair let alone making plans for any expansions.

Alderperson –

- 1. Dale Trinka stated that many people are in favor of a trail but we don't have the necessary funds.
- 2. George Fero stated that the city needs to research and implement some methods to slow down the traffic speeding through town. He suggested some "traffic calming" measures and other methods to slow down cars.
- 3. Ulanda Branch questioned the "no issuing of citations" at traffic accidents. She wanted a legal explanation of the statement Chief Roth said about "the discretion of the officer".
