To whom it may concern,

Attached is a copy of the proposed fire and security alarm system for Lebanon City Hall building and leased spaces.

The process of upgrading a fire alarm notification system to current National Fire Protection Agency (NFPA) and life safety code leaves little room for interpretation. The office of the Illinois State Fire Marshall has minimum requirements that meet and exceed OSHA requirements.

It is our understanding that OSHA is requiring a Fire Prevention Plan and in that plan your fire alarm system would need to be upgraded to meet minimum requirements. For a new fire alarm system to be installed in a preexisting building seeking compliance with the Office of the Illinois State Fire Marshal, a fire alarm plan and drawings of the project would need to be submitted. (You will find this form attached in these documents.)

- City Hall needs to provide current facility dimension drawings for proper submission of a fire alarm plan to the Office of the Illinois State Fire Marshal. Once submitted they will amend or approve an installation of a new fire alarm system.
- Due to improper cable being used for fire alarm devices the current fire alarm cable would need to be replaced to meet code requirements.
- Sleeping areas in the ambulance leased space would need to be reviewed.

We have provided a proposal recommending devices needed to bring the facility up to NFPA code. Ultimately the Office of the Illinois State Fire Marshal would need to be consulted for approval.

SCOPE OF WORK

Installation, new addressable fire system and security system upgrade to existing secured spaces.

FIRE: Wire (with red fire cable) and install 1 fire alarm panel with battery backup, 1 powered NAC panel, one zone expansion module, 18 addressable smoke detectors, 11 addressable rate of rise heat detectors, 2 CO detectors, 5 pull stations, 12 horn strobes, 2 keypad annunciators. 1 UL cellular fire communicator. Test and monitor fire alarm system.

SECURITY: Install all new security peripheral devices, 1 security alarm panel with partitions for separate spaces. 4 glass break detectors, 5 motion detectors, 5 man door contacts, 2 keypads (in conjunction with fire keypads).

This work begins the process of bringing the facility up to current fire and life safety code requirements. Additional work will need to be completed to bring the facility to current code compliance. City Hall would need to provide building drawings in order for a submission to receive approval by the Office of the State Fire Marshall.

Equipment and installation covered under one year parts and labor warranty unless additional service agreement is purchased.

SYSTEM NOTES & OPTIONS

- * All cable and equipment in this proposal are non proprietary and can be monitored or serviced by any company or central monitoring station.
- Systems included all have backup batteries as required by code.
- * Equipment allows for the ability to add devices in the future ie. Ambulance Security, additional Fire Exits and Horn Strobes.
- * System allows for police and fire department to receive building zone trouble device locations and event type information for more efficient response during emergencies.
- * Replacing current security equipment reduces possible cost of current unknown device issues.

- Cox Alarm & Tech Co. labor is provided during normal business hours Monday Friday from 8:00am 4:00pm. Overtime is not included and will be charged additionally.
- All equipment installed by C.A.T.C is warranted for one year parts and labor. Access equipment is covered by three year manufacturer warranty unless extended warranty/maintenance services are purchased. Company provides no warranty of existing equipment.
- Customer must provide unobstructed access to system areas for installation and servicing of devices. Customer must dedicate adequate personnel and equipment resources to ensure that all furniture, merchandise, and equipment are moved away from system device locations. Additional trip charges and labor charges may apply if device areas are not accessible at scheduled time.
- · Any additional work needed to repair or replace any existing faulty equipment will result in additional charges at current service rates.
- Customer is responsible for ensuring adequate lighting is available to maintain desired picture quality, even when light-enhancing video technology is utilized.
- Customer must supply a table, shelf, or computer rack for video recorder/server and power outlets for video system equipment, Power outlets should be connected to an Uninterrupted Power Supply (UPS),
- · Customer must supply Internet connection with available public I.P. address(es) for system equipment.
- · Customer is responsible for all computer network hardware and programming to enable remote viewing of video cameras.
- · If proposed systems are to utilize Customer's Wi-Fi network, the reliability and operation of these systems will be subject to the Customer's Wi-Fi signal strength at the desired camera locations. Wi-Fi related issues are excluded from the camera warranty. Additional Wi-Fi network equipment is available for an additional fee.
